**Course Description:**

This course will provide the student with an introduction to the history, current research, and theories in the field of psychology. The course focuses on a wide variety of topics related to the behavior and mental processes of individuals and groups rather than on one or two specific areas.

**Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- Describe the basic concepts, theories and research within the field of psychology and their implications to professional practice.
- Utilize critical thinking skills as applied to the theories and research within the field of psychology.
- Discuss the various applications of psychological principles within current and future personal and work-related areas of life.
- Apply concepts learned to the external behavioral world to foster further understanding of both individuals and groups.
- Critically assess trends and issues in psychology that has an impact on the students' chosen disciplines.

**Course Format:**

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

## **Appendix 1 Assignment Outlines**

Please note: Students must complete all assignments, tests and Final Exam to pass this course.

### **Daily Tests**

**Due Date: Each class from classes 1 through 8.**

**Weight: 20%**

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded test based on these reading assignments.

### **Class Summary Activity**

**Due Date: Daily (at the conclusion of the class; 1 through 8)**

**Weight: 10%**

Students will be expected to do a reflective response that is centred on what was discussed and learned during the class. This will be done during the last 30 minutes of the class. If you are absent, you will receive a "zero". You will be evaluated using the Short Writing Reflective Rubric.

### **Term Paper**

**Due Date: Class 8**

**Weight: 25%**

This assignment will enable you to critically think about what you have learned and how this impacts you and the way you will approach and work with your clients. Write a term paper that clearly expresses key information or ideas that you have specifically learned or are learning and expand on these points. Explain their impact on you and how they are shaping your thinking/behavior in terms of working with clients in your professional field. Your research and presentation is not to be a review of material in the text, but rather an expanded, more thorough expression of learning that is relevant to you.

Use APA standards and provide at least *three to four academic references* using academic sources like Gale and Google Scholar, in addition to the course text. Minimum length is 1000 words and no more than 1250 words. Please go to your Moodle site for this course and use the Word template prepared for you (E-brary). You do not include the words Running Head or write an Abstract for this paper. Information is provided on how to electronically manage your sources and easily prepare a correct References page. How to format your paper is included in the E-Brary. You may also use your Cites Handbook as the official source for APA at Columbia College. Students will be evaluated according to the attached rubric.

### **Presentation**

**Due date: Class 8 or 9**

**Weight: 15%**

Each student will make a 10 to 15-minute presentation to provide the key points of his or her term paper and be prepared to respond to questions from class members. Students will be evaluated according to the attached rubric.

### **Final Exam**

**Due Date: Class 10**

**Weight: 30%**

Students will be required to write a final exam covering the content of classroom learning and assigned text and other readings. The exam will consist of multiple-choice questions.
