**Course Description:**

Human rights and diversity issues play an important role in Criminal Justice practice. This course will provide students with the opportunity to examine current issues and social problems relating to our current cultural society. It will provide an understanding of diversity and the associated problems and issues surrounding it. Students will also investigate the myths and realities surrounding race, gender, social class, crime, and the roles these issues have played in criminal sentencing. First Nations issues and the factors underpinning the Aboriginal people's overrepresentation in the Criminal Justice system will be investigated in detail.

**Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- Discuss the basic concepts underpinning diversity, multiculturalism, human rights in Canadian context.
- Explain the various rights and freedom enshrined in Canadian Human Rights legislation and practices.
- Discuss cultural and religious diversity and know the ramifications of topics such as family violence, mental health issues and developmental disabilities.
- Discuss the cross-cultural and racial contact that police officers and civilian employees have with citizens, victims, suspects, and co-workers from diverse backgrounds.
- Demonstrate a working knowledge and understanding of cultural diversity in Canadian society and workplace.
- Critically assess the key trends and issues surrounding cultural diversity in Canada, our communities and workplaces.

**Course Format:**

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our

faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

## **Appendix 1 Assignment Outlines**

### **Quizzes**

**Due Date: Daily (at the beginning of each class; 1 through 8)**

**Weight: 20%**

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded quiz based on these reading assignments.

### **Class Summary Test**

**Due Date: Daily (at the conclusion of the class; 1 through 8)**

**Weight: 10%**

Students will conclude each of the classes with a summary of the day's topic that answers the following: "What did I learn? What do I need to know more about? What steps do I need to do to be successful in light of what I learned today?" Be sure to specifically refer to what was discussed during the class. Write in a reflective journaling style and turn your answers into the facilitator for grading. The paper will have a minimum length of 250 words and contain insight into each of these three questions.

Answers are to be written in the last 30 minutes of the class. No answers will be accepted that were prepared prior. If you are absent from the Summary Test, you will receive a "zero".

### **Assignment – Term Paper**

**Due Date: Class 5**

**Weight: 20%**

Students will submit a 1,250 to 1,500-word term paper critically examining a specific diversity group from the text. The student must discuss the topic with the facilitator and submit an outline of the term paper with reference list at the end of the second class. (the outline will comprise 10% of the term paper grade).

The essay must have a minimum length of 1,250 words (not including the cover page and the reference page), use APA standards, and contain at least four references in addition to the course text. Students will be evaluated according to the attached rubric.

### **Presentation**

**Due date: Class 9**

**Weight: 20%**

Each student will make a 10 - 15 minute PowerPoint presentation on the key points or findings of his or her research and be prepared to respond to questions from class members. Students will be evaluated according to the attached rubric.

### **Final Exam**

**Due Date: Class 10**

**Weight: 30%**

Students will be required to write a final exam consisting of multiple choice questions covering the content of classroom learning and assigned text and other readings.
