#### **Course Description:**

This course introduces theories, methods and concepts generally utilized in human services professions. The course examines various theories and methods in these professions, as well as their practical use. Major practice theories and evidence-based theoretical methodologies are explored. The course addresses its main objective: to expand essential theoretical and methodological skills and knowledge in human services professions.

#### **Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- Understand, identify, and apply basic concepts of Human Services profession
- Identify and describe main interventions in Human Services profession
- Understand the role of a human service worker
- Analyze various processes involved in applying Human Services methodologies
- Critically reflect on basic values of Human Services profession
- Increase self-awareness in your practice as a human service worker
- Explain reasons of applying various theories and methodologies in your practice as a human service worker.

#### **Course Format:**

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

# Appendix 1 Assignment Outlines

Research Paper Due: Class 7 Weight: 25%

You are to pick a topic (a theoretical methodology within the context of this course) that you would like to utilize and explore further as a human service worker. Write a research paper on the topic with a minimum length of 1200 words, but the paper is not to exceed a maximum of 1400 words (not including the title page, references, appendixes, table, and figure captions). No abstract is required. You are required to use a minimum of 3-4 academic references (research sources can come from sources like Gale and Google Scholar). Students should refer to their Moodle course site for information on writing a research paper and use of an electronic template. The Cites text is the College's official source to use as a reference. You will be assessed according to the appended Research Paper Rubric.

**Presentation** 

Due Date: Class 8 & 9

Weight: 15%

Students will be expected to present on their findings of their research topic (10-15min). You will be evaluated according to the appended Oral Presentation Rubric.

**Tests** 

Due Date: Each class from classes 1 through 8.

Weight: 20%

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded test based on these reading assignments.

Daily Reflective Summary Activity
Due Date: End of each class from class 1 through 8.
Weight: 10% (1.25% per summary assignment)

Students will be expected to do a reflective response that is centred on what was discussed and learned during the class. This will be done during the last 30 minutes of the class. If you are absent, you will receive a "zero". Students will be evaluated according to the appended Short Writing Reflective Rubric.

Final Exam
Due Date: Class 10
Weight: 30%

Students will be required to write a final essay exam.
