Course Description:

This course will provide the student with an introduction to the history, current research, and theories in the field of psychology. The course focuses on a wide variety of topics related to the behavior and mental processes of individuals and groups rather than on one or two specific areas.

Learning Outcomes:

As a result of active participation in these sessions, a student can expect to:

- Describe the basic concepts, theories and research within the field of psychology and their implications to professional practice.
- Utilize critical thinking skills as applied to the theories and research within the field of psychology.
- Discuss the various applications of psychological principles within current and future personal and work-related areas of life.
- Apply concepts learned to the external behavioral world to foster further understanding of both individuals and groups.
- Critically assess trends and issues in psychology that has an impact on the students' chosen disciplines.

Course Format:

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

Appendix 1 **Assignment Outlines**

Please note: Students must complete all assignments, guizzes and Final Exam to pass this course.

Daily Quizzes

Due Date: Each class from classes 1 through 8.

Weight: 20%

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded quiz based on these reading assignments. Other than approvals that have been established through the Request for Excused Absence form or the Application for Assignment Extension form, no make-up guizzes will be permitted.

Class Summary Test

Due Date: Daily (at the conclusion of the class; 1 through 8

Weight: 10%

Students will conclude each of the classes with a summary of the day's topic that answers the following: "What did I learn? What do I need to know more about? What steps do I need to do to be successful in light of what I learned today?" Be sure to specifically refer to what was discussed during the class. Write in a reflective journaling style and turn your answers into the facilitator for grading. The paper will have a minimum length of 250 words and contain insight into each of these three questions. Answers are to be written in the last 30 minutes of the class. No answers will be accepted that were prepared prior. If you are absent from the Summary Test, you will receive a "zero".

Term Paper Due Date: Class Weight: 25%

This assignment will enable you to critically think about what you have learned and how this impacts you and the way you will approach and work with your clients. Write a term paper that clearly expresses key information or ideas that you have specifically learned or are learning and expand on these points. Explain their impact on you and how they are shaping your thinking/behavior in terms of working with clients in your professional field. Your research and presentation is not to be a review of material in the text, but rather an expanded, more thorough expression of learning that is relevant to you. Use APA standards and provide at least five academic references using ProQuest or Gale in addition to the course text. Minimum length is 1250 to a maximum of 1500 words.. Students will be evaluated according to the attached rubric.

Presentation

Due date: Class 8/9

Weight: 15%

Each student will make a 10 to 15-minute presentation to provide the key points of his or her term paper and be prepared to respond to questions from class members. Students will be evaluated according to the attached rubric.

Final Exam

Due Date: Class 10

Weight: 30%

Students will be required to write a final exam covering the content of classroom learning and assigned text and other readings. The exam will consist of approximately 125 multiple-choice questions.
