### **Course Description:**

This course will explore applied communication theories and principles in resolving conflict and management of crisis situations. Students will be provided with skills and techniques to intervene with competence and confidence in conflict and crisis situations. An additional area to be addressed with be suicide intervention. In this course the student will receive training in crisis management and successful students will receive a Non-Violent Crisis Intervention Certificate.

### **Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- 1. Define the common terminologies, concepts, and models in the study of conflict and crisis intervention.
- 2. Discuss the formulae for understanding the process of crisis formation and for increasing functioning (leading a client out of a crisis).
- 3. Explain, analyze and apply the ABC model of crisis intervention and its various components.
- 4. Create a script using the ABC model of crisis intervention.
- 5. Apply various communication techniques to de-escalate crisis situations.
- 6. Apply non-violent crisis intervention strategies.
- 7. Critically assess each of the strategies and techniques used for assessing conflict situations.

### Course Format:

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

### **Assessment Information**

### **In-Class Learning Activity**

Due Date: Classes 1 through 8

Weight: 10% (4 learning activities at 2.5% each)

Students will be expected to actively participate in experiential-based learning activities designed to apply the principles and concepts learned in class. Students will be provided with specific guidelines on each learning activity. Students will be evaluated according to the attached rubric.

### **Term Paper**

Due Date: Class 8 Weight: 25%

Students will submit a 1,200 to 1,500-word term paper critically examining a relevant text topic of choice. Students should apply the principles of the text topic to their particular career focus. Students must use a minimum of four sources in addition to the course text and the submission must be to APA standards. Students will be evaluated according to the attached rubric.

### **Class Participation**

Weight: 5%

### Quizzes

Due Date: Each class from classes 1 through 8.

Weight: 20%

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded guiz based on these reading assignments.

### **Presentation**

Due date: Class 9 Weight: 10%

Each student will make a 10-minutes PowerPoint or use other presentation software to present on his/her findings on his or her term paper topic and be prepared to respond to questions from class members. Students will be evaluated according to the attached rubric.

### **Final Exam**

Due Date: Class 10

Weight: 30%

Students will be required to write a final exam covering the content of classroom learning and assigned text and other readings. The exam will consist of 75 to 100 multiple-choice questions.
