Course Description:

This course examines how to work with a variety of special needs offenders. The course looks at legal rights, laws, processes and practices relevant to assessment, management, and advocacy, and the risks and rewards involved in working with special needs offenders.

Learning Outcomes:

As a result of active participation in these sessions, a student can expect to:

- Understand, explain, and discuss basic terminologies associated with understanding and working with special needs offenders in the Criminal Justice system and the community at large.
- Discuss the various four general stages and methods for effective program supervision and evaluation of special needs offenders.
- Learn how to critically assess the various types of special offenders and explain a treatment prognosis for each type of offender.
- Explain the basic concept and mechanics of restorative justice and how this relates to the topic at hand.

Course Format:

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

Appendix 1 Assignment Outlines

Assessment Information

Research Paper

Due Date: Class 8

Weight: 30%

Students will prepare a term paper on a current issue or trend relating to the course topic. The paper must have a minimum length of 1,250 words (excluding the cover page and the reference page), use APA standards, and contain at least four references in addition to the course text. Students will be evaluated according to the attached rubric.

Quizzes

Due Date: Each class from classes 1 through 8.

Weight: 20% (2.5% per quiz)

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded test based on these reading assignments.

Oral Presentation

Due date: Class 9

Weight: 15%

Each student will make a 8- to 10-minute PowerPoint presentation on the key points of his/her Research Paper or any relevant topic pre-approved by the facilitator and be prepared to respond to questions from class members and the facilitator. Students will be evaluated according to the attached rubric.

Class Participation

Due Date: Evaluated throughout

Weight: 05%

Students will be evaluated according to the 'Student Engagement' rubric found at the end of the syllabus.

Final Exam

Due Date: Class 10

Weight: 30%

Students will be required to write a final exam consisting of 100 multiple-choice questions covering the content of classroom learning and assigned text and other readings.


