#### Canadian Criminal Law and the Court System (CRIM135)

#### **Course Description:**

This course investigates the nature, purpose, sources, and principles of Canadian criminal law. Current policy and specific legislation in the Criminal Code will be examined in detail. The various levels and goals of the courts (federal, provincial, municipal) will be discussed. The major structures of the courts, basic procedures and legal concepts will be explored. A special emphasis will be placed on the criminal court systems. Prerequisite: None.

#### **Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- Identify and explain each of the various levels and functions of the Canadian court system.
- Critically assess the impact of the Canadian Charter of Rights and Freedoms on the criminal law in Canada.
- Explain the *actus reus* (physical act) elements of a criminal offense and exceptions to the general rule.
- Discuss the *mens rea* (mental) elements in the criminal law both subjective and objective liability.
- Distinguish between strict and absolute liability in Canada.
- Evaluate each of the modes of participation in crime and inchoate offenses.
- Interpret the general legal principles on mental impairment and criminal responsibility.
- Explain the general legal principles governing mistake of fact, consent, and mistake of law as defenses to a criminal charge.
- Critically evaluate the general principles governing provocation, intoxication, necessity and duress as
  defenses to a criminal charge.

#### **Course Format:**

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

## Appendix 1 Assignment Outlines

**Daily Tests** 

Due Date: Each class from classes 1 through 8.

Weight: 20%

Students will be expected to read the assigned chapters in the text and other assigned readings including APA formatting, and be prepared to write a graded test based on these reading assignments.

**Class Summary Test** 

Due Date: Daily (at the conclusion of the class; 1 through 8)

Weight: 10%

Students will conclude each of the classes with a summary of the day's topic that answers the following: "What did I learn? What do I need to know more about? What steps do I need to do to be successful in light of what I learned today?" Be sure to specifically refer to what was discussed during the class. Write in a reflective journaling style and turn your answers into the facilitator for grading. The paper will have a minimum length of 250 words and contain insight into each of these three questions.

Answers are to be written in the last 30 minutes of the class. No answers will be accepted that were prepared prior. If you are absent from the Summary Test, you will receive a "zero". Students will be evaluated according to the appended Short Writing Reflective Rubric.

Critical Analysis Paper Due Date: Class 5 Weight: 20%

Students will prepare a critical analysis paper on a topic of interest based around Criminal Law and the Court System in Canada.

#### Possible topics:

- Mental Impairment and Criminal Responsibility as Defences to a Criminal Charge
- Mistake of Fact, Consent, and Mistake of Law
- Necessity and Duress as Defences
- Self-Defence and the Defence of Property

Students should refer to their Moodle course site for information on writing their term paper and use of an electronic template. The *Cites* text is the College's official source to use as an APA Reference. The paper will have a minimum length of 1250 words, but is not to exceed a maximum length of 1400 words (not including the title page, references, appendixes, table, and figure captions). The paper should meet APA standards. No abstract is required. The paper should have at least four references from journals like Gale, in addition to reference to the course text. Students will be evaluated according to the attached rubric: Critical Analysis Essay Rubric.

**Oral Presentation** 

Due date: Class 8 and/or 9

Weight: 20%

Each student will make a 10- to 15-minute PowerPoint presentation on the salient points of his/her Assignment #2 paper and be prepared to respond to questions from class members. Students will be evaluated according to the attached rubric.

**Final Exam** 

Due Date: Class 10

Weight: 30%

Students will be required to write a final exam covering the content of classroom learning and assigned text and other readings.
