Course Description:

This course is an introduction to communication within a Criminal Justice work environment context. Students will learn case management strategies and best practices through application to case studies and gain an understanding of the helping relationship in the justice system. Students will learn critical thinking, public speaking, making reports, note-taking, interviewing, communicating with various types of publics, and related activities. Students are required to complete weekly text and handout reading assignments and participate in discussions with the facilitator and fellow students.

Learning Outcomes:

As a result of active participation in these sessions, a student can expect to:

- Define and apply foundations in criminal justice case management practice
- Demonstrate attitudes for effective communication in coordinating the case management process
- Create a client-centered case management plan
- Develop a case audit and monitor case management practice

Course Format:

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

Appendix 1 Assignment Outlines

Quizzes Due Date: Daily (at the beginning of each class; 1 through 8) Weight: 20%

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded quiz based on these reading assignments.

Class Summary Test Due Date: Daily (at the conclusion of the class; 1 through 8) Weight: 10%

Students will conclude each of the classes with a summary of the day's topic that answers the following: "What did I learn? What do I need to know more about? What steps do I need to do to be successful in light of what I learned today?" Be sure to specifically refer to what was discussed during the class. Write in a reflective journaling style and turn your answers into the facilitator for grading. The paper will have a minimum length of 250 words and contain insight into each of these three questions.

Answers are to be written in the last 30 minutes of the class. No answers will be accepted that were prepared prior. If you are absent from the Summary Test, you will receive a "zero". You may appeal the decision by following the Appeal Policy.

Assignment; Term Paper Due date: Class 5 Weight: 20%

Students will prepare a critical analysis essay, focused on case work and methodology, with respect to one of the topics listed below. The essay must have a minimum length of 1,250 words, use APA standards, and contain references from at least <u>three</u> sources. Students will be evaluated according to the Critical Analysis Essay rubric.

Presentation Due date: Class 9 Weight: 20%

Each student will make a 10- to 15-minute PowerPoint presentation to present the salient points of his/her research paper process and findings OR topic approved by facilitator and relevant to the course. Assignment paper and be prepared to respond to questions from class members. Students will be evaluated according to the attached rubric.

Final Project Due Date: Class 10 Weight: 30%

Format: (Word Processed or presentation format)

Introduction: Provide précis of topic sufficient to indicate understanding of issues to be discussed. (5%)

Case Management (CM) and Methodology Issues: Identify organizational and professional, case management and methodology issues to be discussed with respect to the Case Study. (5%)

Application: Analyze and evaluate the identified case management and methodology issues in the case study from the perspective of appropriate CM themes in the Course Bundle and other research materials, as appropriate. (15%)

Research: Provide details of research methodology undertaken and reference sources. (5%)
