# **Course Description:**

The course includes facilitation in both conceptual and functional computer understanding. Conceptual literacy is the key focus of the lectures. These lectures devote special attention to current computer topics and tools from the perspective of its use by professionals in human services. Topics include using and evaluating technology for research, digital inclusion, privacy and security, net addictions, cyberbullying and parental controls, and communication tools. Functional computer literacy is the key focus of weekly labs. This part of the course teaches basic computer skills in Microsoft Word and Excel. Throughout this course, students will be introduced to a number of current web-based technologies, and challenged in discussions relating to their use and application to the profession of Human Services.

# **Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- Demonstrate an awareness of keyboarding benchmarks in the profession, as well as to speak to the importance of outlining personal development goals in this area.
- Demonstrate an understanding of the practical application of Cloud computing and the various leading tools introduced throughout the course.
- Understand the fundamentals of finding credible information online and be able to demonstrate the
  use of different support resources to solve basic computer-related problems.
- Be able to describe key positions relating to the digital divide, and its impact on our society.
- Understand the basics of computer security, and be able to discuss preventative and corrective solutions to security-related problems.
- Demonstrate a foundational understanding of Net Addictions, Cyberbullying, and Parental Controls and be able to point to online resources accordingly.
- Demonstrate an understanding of social networking, some of the leading resources, as well as some
  of their strengths and weaknesses.
- Use Microsoft Word, Excel, and other related software for regular applications associated with Human Services professionals.

#### **Course Format:**

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

#### **Submission and Completion of Assignments:**

**Quizzes** 

**Due Date: Classes 1-8** 

Weight: 10%

Students will be expected to read the assigned articles and be prepared to write a graded quiz based on these reading assignments. Reading assignments will be posted on Moodle.

Reflective Summaries
Due Date: Classes 1, 3, 5, 7

Weight: 10%

Students will conclude the class with a summary of the day's topic(s) that answers the following:

- 1. What did I learn?
- 2. What do I need to know more about?
- 3. What steps do I need to do to be successful in light of what I learned today?

Be sure to specifically refer to what was discussed during the class. Write in a reflective journal style and submit your reflective summary prior to the end of class. The summary will have a minimum length of 250 words and should contain insight into each of the three questions listed above.

Answers are to be written in the last 30 minutes of class. Students absent from the Reflective Summary, will receive a grade of zero.

Technology Journals

6 Journal Entries consisting of any of the following:

- Review of a current IT based story (In the news)
- App Review (Computer or phone apps)
- Website Review

2 journal entries are due at the beginning of each of Class 3, 7 and 9.

Each journal assignment should normally be 250-350 words in length, and contain a link to the original article, app, or website. In your journal, you must provide the following:

# IT News Story Journal:

What is the story? Why is it relevant? Reaction from community? Impact on industry and/or future career path? Is the resource credible (why or why not)?

#### **APP Review:**

What is the application, computer program ... for what kind of computer device? Why is it relevant? Reaction from community? Impact on industry and/or future career path?

#### Website Review:

What is the website's purpose? Why is it relevant? Is the website credible (why or why not)? Impact on industry and/or future career path?

The Computer Learning Journals will be worth a total of 20%, and will be graded on the following:

1 Mark	Appropriate Sources Used and Cited (ie. a cite or topic related to your career)
1 Mark	Content (falls within the 250-350 length and contains minimal spelling, grammar or punctuation errors)
1 Mark	Impact on industry and/or career path is addressed and relevant.

**Final Exam** 

Due Date: Class 10

Weight: 30%

Students will be required to write a combination multiple-choice, short-answer and/or skill-based final exam covering the content of classroom learning, assigned text and other readings, and the Computer Labs. The final will include the following:

- 30 Multiple Choice questions (25%)
- 2 Short-answer, essay-type questions (25%)
- Microsoft Word skill-based activity (25%)
- Microsoft Excel skill-based activity (25%).
