#### **Course Description:**

This course focuses on providing instructional support to learners through practical classroom-tested strategies. It brings together theory and practice in authentic, meaningful, and productive ways.

#### **Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- Discuss how students in language arts classrooms are served in today's schools.
- Understand the contents and importance of the language arts curriculum at various levels: Listening;
   speaking; reading; writing; viewing and representing.
- Discuss current issues and trends that affect language arts instruction.
- Become familiar with practical classroom-tested strategies that work with students of all ages across
  the various curricula.
- Discuss the role of equity, diversity and social justice in the school environment.
- Understand assessment and evaluation and reporting of student progress.
- Explain how differentiated instruction and curriculum meets the needs, interests, and abilities of all students.
- Demonstrate knowledge of importance of technological literacy and what constitutes a technologyrich classroom.
- Develop a basic understanding of literacy and language learning.

#### **Course Format:**

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

## Appendix 1 Assignment Outlines

Assignment #1: Meeting Student Needs in an Inclusive Classroom

Due Date: Class 7 Weight: 20 %

#### **Evaluation: Rubric provided**

- You will design a toolkit to meet the needs of a target group of special needs students or student in an inclusive classroom. You must do the following:
- Clearly identify the target group of special needs students. You could prepare for one special needs student. Provide adequate description so that enough information is provided to understand your focus group/student. Do not use a names/s.
- Identify curriculum/learning objectives for the students.
- Describe strategies to support and enhance curriculum/learning objectives.
- Explain why you think the strategies will be effective.
- What you present in this toolkit should demonstrate:
- Knowledge of Alberta Education's curriculum
- Knowledge of Alberta Education's Inspiring Education
- An understanding of the diverse needs of students in the classroom (cultural relevance, English Language Learners (ELL), students with medical conditions, learning disabilities, etc.) and proof that you are considering the accommodations they require.
- You have researched to prepare this toolkit (minimum of five reputable sources)

**Assignment #2 - Presentation** 

Due Date: Class 9 Weight: 10 %

**Evaluation: Rubric provided** 

You will present your toolkit from Assignment 1 during a 15-20 minute presentation with opportunity for questions for 10 minutes.

#### Quizzes

Due Date: Each class from classes 1 through 8.

Weight: 20% (2.5% per quiz)

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded quiz based on these reading assignments.

#### **Summary Tests**

Due Date: Each class from classes 1 through 8. Weight: 20% (2.5% per summary assignment)

Students will be expected to respond to a Summary Test assigned by the facilitator, administered during the last 30 minutes of the class to determine what you have learned during the class and your readings. If you are absent from the summary assignment, you will receive a "zero". You may appeal the decision by following the Appeal Policy and submitting your request to the Registrar's office.

Final Exam – Project Due Date: Class 10 Weight: 30%

**Evaluation: Rubric provided** 

The focus of this project is to demonstrate your knowledge of how you will provide instructional support through practical classroom-tested strategies. You are to bring theory and practice together. Select 10 different practical supportive strategies for each of the following curriculum areas – English Language Arts and Mathematics:

- describe each strategy
- who you would use each strategy with
- explain how you would use each strategy
- explain why you chose each strategy (connection to theory and practice)
- how each strategy will support the learner

This will make a total of 20 strategies. Provide citation and references according to APA. Your project should be sent electronically to your facilitator no later than 11:59 p.m. on the date due. It is your responsibility to ensure that the facilitator has received your project.
