Course Description:

This course informs and engages students on issues, theories and concepts and trends in gender and women's studies. The course examines various spectrums in the field, such as government policies, technology and the media and impacts on women and gender. Women's theories, such as feminism, current and historical movements, as well as their influences are analyzed. Issues of sexuality, including reproduction, gender violence and gender relations are also explored, for example: What is gender equality? What is gender power?

Learning Outcomes:

As a result of active participation in these sessions, a student can expect to:

- Demonstrate an understanding that gender operates on four different dimensions within our society: individual, interactional, institutional, and socio-cultural dimension
- Identify how family of origin affects one's perspective on gender
- Identify how the socio-cultural landscape is gendered and shapes our experience
- Describe the two key "lenses of gender" in our culture as they relate to difference and inequality
- Trace the development of feminism and identify their positions in terms of inequality and the rearrangement of the positions of women and men in society
- Analyze the stereotypes about the qualities of women and men as normative expectations against which people judge themselves and others
- Analyze how language and the media plays a major role in transmitting culture and shaping the gendered socio-cultural landscape
- Explain the impact of socialization creates gendered individuals who at adulthood perform gender in the course of making decisions about their lives
- Analyze how social structure and social institutions shape our actions and beliefs and how we choose our beliefs and ways of acting

Course Format:

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

Appendix 1 Assignment Outlines

Please note: Students must complete all assignments, tests, and final exam in order to pass this course.

Term Paper Assignment Due Date: Class 8 Weight: 25%

For the Term Paper Assignment, you have two options to pick from. Please see the options below. For both options the paper must have a minimum length of 1200 words (excluding the cover page and the reference page). Students will be evaluated according to the attached term paper rubric.

Option 1: Cartoon Study

Spend a half hour watching children's cartoons (not adult ones like Simpsons). Analyze the show and the advertising from the perspective of women and gender portrayal to children. Use the following questions as guidelines:

- 1. Look at the physical appearance of the characters in the show. How do they look eye colour, hair colour, etc.? How do they dress? Do they speak with "different" accents? Depict various races?
- 2. What roles do the characters play? Are there differences in the roles?
- 3. Look at the advertising during the show. What is being advertised? Who is doing the advertising? Again, look at dressing, eye colour, hair colour, etc. Age range/s?
- 4. If a child was watching this show, what would she learn from it about the world and her role in the world?

Write your term paper and incorporate all the questions. While you will be reporting on what you observed, you will also be providing critical analysis. This option requires reference to your text and 3-4 references (using such sources like Gale and Google Scholar). Use APA standards to write the paper. Refer to your Moodle course site E-brary for an electronic Essay template to use. Your Cites handbook is the official resource for APA citation.

Option 2: Issue Based Term Paper

Select an issue that appeals to you on the topic of Women and Gender Issues. Write a term paper that expresses your thoughts on the issue and presents well-researched evidence to support the existence of your issue and your opinions on the issue. This option requires reference to your text and 3-4 references (using such sources as Gale and Google Scholar). Use APA standards to write the paper. Refer to your Moodle course site E-brary for an electronic Essay template to use. Your Cites handbook is the official resource for APA citation.

Presentation

Due date: throughout the course as scheduled

Weight: 15%

Each student will be responsible for reading, summarizing, analyzing and presenting one current event relating to a class topic/s. You are connecting concepts in the reading (or readings) and a "real-life example" found in the news, magazines, etc. You do not need to present the current event through a PowerPoint Presentation. You will be allocated 10 minutes for the presentation and another 5-10 minutes for discussion. Sign up for these presentations will begin during the first class. Students will also need to prepare one or two discussion questions. Students will be evaluated according to the Oral Presentation Rubric provided.

Tests

Due Date: Each class from classes 1 through 8.

Weight: 20% (2.5% per test)

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded test based on these reading assignments.

Daily Summary Activity

Due Date: End of each class from class 1 through 8. Weight: 10% (1.25% per summary assignment)

Students will be expected to do a reflective response that is centred on what was discussed and learned during the class. This will be done during the last 30 minutes of the class. If you are absent, you will receive a "zero". You will be evaluated using the Short Writing Reflective Rubric.

Final Exam

Due Date: Class 10

Weight: 30%

This will consist of a Final Reflection paper that allows you to pull together the knowledge learned throughout the course and demonstrate your level of self-awareness and understanding of issues discussed and studied in this course.
