#### **Course Description:**

This course will focus on how to work cooperatively and communicate effectively with others in successful teams. The student will study group dynamics, explore strategies for forming teams, establishing team goals, using effective team behaviours, and acquiring team leadership. Students will also study various conflict management models.

#### **Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- Become familiar with group dynamics and how to be part of productive working team/group relationships.
- Learn the tools for working in successful team (how to relate to others and team members in a
  positive, respectful way, build effective relationships with people at all levels of the organization).
- Understand how to manage workplace conflict (recognize how you and others react to conflict and know how best to address conflict more constructively, handle recurrent conflict, resolve issues with colleagues and preserve good working relationships under workplace stress).
- Learn group problem-solving and decision-making to reach a well-considered decision.
- Increase cultural competence (understand how to work effectively with people from other cultures and backgrounds within an environment of involvement and acceptance).
- Show drive and initiative, a commitment to invest yourself in the workplace with other team members and make you invaluable to your organization.
- Learn techniques for leading teams, how to lead and take the right action, i.e. "do what is right" and how to demonstrate inspiring leadership.
- Foster open communication, and create and environment in which work colleagues can share opinions and ideas with you.
- Speak with impact, write effectively and listen attentively (showing a genuine interest in others and the ability to clarify what has been heard and demonstrate understanding) to team / group members.

#### **Course Format:**

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

# Appendix 1 Assignment Outlines

Research Assignment Due Date: Class 8 Weight: 20%

Description: You will investigate and prepare a report on the importance of having leadership and conflict management skills in your area of specialization. Please select 5 important qualities/skills (you relate with) that a Human Service professional/leader must possess in order to succeed in your career. Explain whether you have these qualities/skills or are developing these qualities/skills and how you are developing or planning to develop these needed qualities/skills. Please note that you can use your textbook as a reference in describing and identifying these qualities. Use a minimum of five academic references supporting your investigation. Your paper will have an introduction, main body, summary and conclusion. Your conclusion should contain a personal reflection concerning the qualities you expressed. Besides the information found in the text, your paper must meet the following criteria:

- Have a word count of 1500 words
- Have minimum of 5 references using ProQuest and/or Gale; other reputable sources can be considered. If you are uncertain of the source, please check with the facilitator
- Follow APA citation and format.

Hand in your paper copy to your facilitator. It is due during the class of the due date — Class 8 - as stated in this syllabus. It is your responsibility to ensure that the facilitator has received your paper copy (which you have printed).

Please <u>avoid</u> emailing your **Research paper** (as your facilitator has to print out your paper and **does not** have immediate access to a printer or unlimited free printer ink for multiple student papers).

#### Quizzes

Due Date: Each class from Classes 1 through 8

Weight: 20%

Description: Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded guiz based on these reading assignments.

**Daily Summary Activity** 

Due Date: End of each class from Classes 1 through 8

Weight: 10% (1.25% per summary assignment)

Description: Students will conclude each of the classes with a summary of the day's topic that answers the following: "What did I learn? What do I need to know more about? What steps do I need to do to be successful in light of what I learned today?" Be sure to specifically refer to what was discussed during the class. Write in a reflective journaling style and turn your answers into the facilitator for grading. The paper will have a minimum length of 250 words and contain insight into each of these three questions. N. B. These three questions are there to guide your answers to this assignment, and your facilitator may give you different questions per class, depending on the lessons of the class.

Answers are to be written in the last 30 minutes of the class. No answers will be accepted that were prepared prior. If you are absent from the Summary Test, you will receive a "zero".

#### Presentation

Due Date: Class 8 or 9

Weight: 20%

Description: Each student will make a 10- to 15-minute PowerPoint presentation on his or her Research Assignment and be prepared to respond to questions from class members. Be sure to prioritize the qualities/skills you will talking about. Students will be evaluated according to the attached rubric.

Final Exam Due Date: Class 10 Weight: 30%

Description: Your final exam is a reflective paper that will demonstrate your understanding of your leadership role in human services. You will be assigned a topic (in this area) to write on at the test centre.
