Course Description:

Fitness and wellness in the criminal justice career are important behaviours for personnel in public and private police organizations, correctional facilities and justice institutions. The course is designed to assist the learner in preparation for the standards set throughout Alberta and Canada for occupational health and wellness. Students explore the concepts of wellness with an emphasis on fitness, stress management, and providing practical strategies for developing sustainable healthy lifestyles. This course will begin with the understanding and building a plan for fitness as a lifestyle for job performance.

Learning Outcomes:

As a result of active participation in these sessions, a student can expect to:

- Explain for the concepts of fitness, active living, health and wellness.
- Utilize the Federal, Provincial and Municipal agencies fitness standards to construct a personal fitness plan.
- Develop a fitness plan that identifies the schedule, types of activities and degree of effort required.
- Demonstrate practical knowledge about the relationship between lifestyle and nutritional choices and the effects on wellbeing and career success.

Course Format:

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

Appendix 1 Assignment Outlines

Daily Quizzes

Due Date: Each class from classes 1 through 8.

Weight: 20% (2.5% per quiz)

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded quiz based on these reading assignments. Other than approvals that have been established through the Request for Excused Absence form or the Application for Assignment Extension form, no make-up quizzes will be permitted.

Daily Summary

Due Date: Each class from classes 1 through 8.

Weight: 10%

Students will conclude each of the classes with a summary of the day's topic that answers the following: "What did I learn? What do I need to know more about? What steps do I need to do to be successful in light of what I learned today?" Be sure to specifically refer to what was discussed during the class. Write in a reflective journaling style and turn your answers into the facilitator for grading. The paper will have a minimum length of 250 words and contain insight into each of these three questions. Answers are to be written in the last 30 minutes of the class. No answers will be accepted that were prepared prior. If you are absent from the Summary Test, you will receive a "zero".

Fitness Assessment Test and Debrief

Due date: Class 9

Weight: 10% (Participative)

Each student will have the opportunity to participate in a provincially recognized criminal justice fitness assessment (APREP, PARE or Equivalent). Upon completion of the assessment the student will participate in a debrief meeting highlighting strategies on a progression towards readiness in a recruitment process. Students will be evaluated according to the level of their participation.

Term Paper and Fitness Plan Assignment Due Date: Class 6

Weight: 30%

Students will prepare a self-reflective term paper responding to an instructor assigned research question. This term paper will allow the student to reflect on the academic growth and apply it to the physical requirements of the criminal justice profession. Throughout the reflection, the student shall make a case for how this experience has stimulated growth and learning in health and wellness. The student will approach the conclusion by describing a fitness plan to use in preparation for a career in law enforcement, youth justice and corrections. The essay must have a minimum length of 1,500 words, use APA standards, and contain at least four references. Students will be evaluated according to the attached rubric.

Final Exam

Due Date: Class 10 Weight: 30%

Students will be required to write a final exam covering the content of classroom learning and assigned text and other readings. The exam will consist of approximately 120 multiple-choice, short answer and applied case study questions drawn from the entire course.
