Course Description:

This course will serve as a practical introduction to the field of sociology. Students will be able to identify and explain the significance of some of the phenomena, methods, and theories of sociology; differentiate between sociological and other questions, theories, and approaches; and interpret a variety of data arrays in order to assess and make sociological arguments. Related theory, research and analysis related to the field will be examined.

Learning Outcomes:

As a result of active participation in these sessions, a student can expect to:

- Identify and explain the significance of some of the phenomena, methods, and theories of sociology.
- Differentiate between sociological and other questions, theories, and approaches.
- Explain in your own words some of the key concepts of sociology.
- Interpret a variety of data arrays in order to assess and make sociological arguments.
- Contribute to a group analysis of "both sides" or opposing viewpoints on a controversial issue.
- Compose and present an individual position paper on a controversial issue using course materials and concepts.
- Apply the concepts, theories, and principles learned from this course to hypothetical situations.
- Communicate information learned from this course to both specialist and non-specialist audiences.

Course Format:

This course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in class discussions and take responsibility for your own learning. Be a positive and co-operative team member. Columbia College uses a facilitation model of instruction where the facilitator's role is to facilitate your learning. The expectation is that you will come to class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you have a tendency to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

Appendix 1 Assignment Outlines

Research Assignment Due Date: Class 9 Weight: 30%

Students will be required to complete a research paper on a topic of their choice. The paper must consist of a critical analysis of the topic by utilizing sociological concepts and theories. Students must have a minimum of two (2) academic references (Wikipedia will not be considered a reference), and use APA format for referencing.

Papers must be in APA Style (View a tutorial on APA Style at http://www.apastyle.org/learn/tutorials/basics-tutorial.aspx). Papers in APA Style should include, in the following order, as many of the following sections as are applicable, with each beginning on a new page: title page, which includes a running head for publication, title, and by-line and affiliation; abstract; text; references; appendixes; author note; footnotes/endnotes; tables; figure captions; and figures. Papers should be typed on standard-sized paper (8.5 X 11 inches), and must not exceed a maximum length of 6 pages or 1500 words (not including the title page, abstract, references, appendixes, footnotes, tables, figure captions, and figures), double-spaced, with margins of one (1) inch on all sides.

Students will be evaluated according to the attached rubric.

Quizzes

Due Date: Each class from classes 1 through 8.

Weight: 20%

Students will be expected to read the assigned chapters in the text and other assigned readings and be prepared to write a graded guiz based on these reading assignments.

Oral Presentation Due date: Class 9 Weight: 15%

Each student will make a 7- to 10-minute PowerPoint presentation on the key points of his or her research paper and be prepared to respond to questions from the facilitator and class members. Students will be evaluated according to the attached rubric.

In-Class Learning Activities
Due Date: Evaluated throughout

Weight: 20% (5% for each learning activity)

The group exercise is intended to generate interactive discussion and sociological analysis of supplemental material on a topic that will be covered in class. Specifically, students should apply theory and basic concepts from the text and class to their analysis of the material. The material will be provided by the facilitator one class prior to the exercise, with students expected to read the material prior to attending class. Students will be required to interact with 3 to 4 of their peers, and are encouraged to work with different peers, for each of the five exercises. Students will be marked individually based on their group answers that are to be submitted individually on standard worksheet that will be provided before the exercise. Each activity is worth 5% for a total of 20% of a student's final grade.

Final Exam

Due Date: Class 10

Weight: 30%

Students will be required to write a final exam consisting of approximately 120 multiple questions and covering the content of classroom learning and assigned text and other readings.
