**Course Description:**

This course offers the student an opportunity to explore key topics and issues focusing on their area of specialization. Primary and secondary research will be used to prepare a major project on the topic/topics of choice.

**Learning Outcomes:**

As a result of active participation in these sessions, a student can expect to:

- Define, explain, and describe key terms, concepts, theories, ideologies, and models.
- Apply and critically analyze ethics related to your profession.
- Summarize a human services approach to working with individuals experiencing poverty, unemployment, and other associated challenges.
- Identify and discuss how children and families are affected by parenting style, family type, and family violence.
- Describe how social services workers work with diverse populations such as seniors, Indigenous Canadians, immigrants, and individuals with disabilities,
- Articulate an understanding of social agencies for delivering social welfare resources to people in need through strategic and operational frameworks.
- Understand the social welfare system and critically assess its issues, roles, approaches, initiatives, and challenges.
- Discuss the role of professional and non-professional service providers within the social welfare provision.
- Demonstrate professional and personal growth in human services through self-assessment activities.
- Summarize the process of how social welfare policies are formalized, implemented, and evaluated.

## **Course Format:**

This 45-hour remote course uses a variety of teaching/learning methods including discussion, personal reflection, experiential exercises, student presentations, role-plays, group activities and especially case studies. Our faculty aims to create a learning environment where the learner is actively engaged in inquiry, critical thinking and problem solving. The online classroom provides you with a place where you can learn with and from others in a cooperative and collaborative manner.

You are expected to take a very active part in online class discussions and take responsibility for your own learning. Be a positive and co-operative team member. The expectation is that you will come to each online class prepared with pre-class homework completed. Your facilitator will engage you in activities that are based on your completed homework and readings. Your enthusiastic and positive approach in the online setting classroom will create an atmosphere that will help every student develop the knowledge, skills and attitudes that are needed for success.

How you conduct yourself in our online classes will, to a large extent, mirror your conduct in society and your future work site. For example, if you tend to ask questions, challenge the ideas of others in a respectful manner, draw out the best from your colleagues, and encourage both group development and task accomplishment in this class, it is likely you will do the same at work. A high level of student involvement and developing professionalism is expected in the classroom as you work towards your goal.

## **Appendix 1 Assignment Outlines**

**Please note: Students must complete all assignments, tests, and final projects to pass this course.**

### **Daily Tests**

**Due Date: Each class from classes 1 through 10.**

**Weight: 20%**

Students will be expected to have read the assigned chapters in the text and other assigned readings and be prepared to write a graded test based on these reading assignments.

- Tests are open in Moodle from 8:30 AM the day of the scheduled class to 11:59 PM the following day.
- There is one attempt.
- There is a 30-minute time limit on each test (unless otherwise noted)

### **Asynchronous Activities**

**Due Date: Classes 4, 6 & 8**

**Weight: 15%**

Asynchronous activities are those that take place outside of the live lecture/class time. They are intended to build upon critical thinking skills based on material connect to or assigned for that day. Activities are assigned at the conclusion of a live lecture with explicit directions and completion dates. Facilitator support is available should there be any queries.

Asynchronous activities may include but are not limited to:

- Case study review and assessment
- Video responses

### **Writing Assignment A Critical Response**

**Due: Class 5**

**Weight: 20%**

This assignment is designed to help you gain an understanding of Canadian social policy. In this assignment, using early chapters of the course text, you will analyze various aspects of social policy in Canada, focusing on its historical development, current state, and potential future directions. You will also explore the impact of these policies on the well-being of Canadian citizens.

A good place to focus will be Chapter 2 with the progression of social policy in Canada.

Things to consider:

- Canada up to 1945
- Institutional Approach
- The Market-State Approach

Explore potential directions of social policy based on your understanding of Canadian Social policy trends and observations in your text. What are some changes you would like to see made? What are some mistakes the government may have made in implementing or reducing policies? Be specific with your examples.

### Writing Assignments Expectations:

- **Objective:** The objectives of this writing assignments are to critically apply concepts, ideas, and procedures to facilitate higher level learning. The assignments are designed so students can demonstrate depth of knowledge related to the course content.
- **Focus:** Each assignment is designed to apply knowledge from the chapters and class discussions.
- **Format:** All assignments will be double-spaced. Do not include title pages. Include your name at the top of each page. A minimum of one-inch margins on each side. 12-point Calibri font is preferred. Each assignment should have a minimum length of 500 words but is not to exceed 750 words. Students will be evaluated according to the attached rubric: **Critical Writing Response Marking Rubric.**
- **How to avoid plagiarism:** The simplest way to avoid plagiarism is to reference any sources properly (using both in-text, parenthetical citations in the body of your assignment and a 'References' page at the end). While it is commonplace to build upon the knowledge of others, it is necessary to clearly state the sources and foundations of that knowledge. Referencing must conform to the APA style- see your ENG110 text for support.

### Writing Assignment B Critical Response

**Due: Class 7**

**Weight: 25%**

Considering the history of diverse people in Canada and the various social welfare policies and structures that have been created for them, write a critical analysis that focuses on what a social services professional should consider when encountering diverse clients in their respective work environments.

This assignment focuses on Chapter 6: *Diversity and Social Policy*. NOTE: this chapter uses the word "Aboriginal" but the more commonly accepted term is Indigenous – ensure you use the modern language in social services/public settings.

Things to consider:

- Canadian practices – past and present
- Legislation enacted upon diverse people.
- desire for autonomy for diverse individuals
- What "position" should a social service professional take when encountering diverse clients?
- What histories can/should a social services professional study should they be willing to learn about being an ally for diverse peoples? You can bring in your personal experiences as someone who is considered "diverse" or working with diverse peoples.

### Writing Assignments Expectations:

- **Objective:** The objectives of this writing assignments are to critically apply concepts, ideas, and procedures to facilitate higher level learning. The assignments are designed so students can demonstrate depth of knowledge related to the course content.
- **Focus:** Each assignment is designed to apply knowledge from the chapters and class discussions.
- **Format:** All assignments will be double-spaced. Do not include title pages. Include your name at the top of each page. A minimum of one-inch margins on each side. 12-point Calibri font is preferred. Each assignment should have a minimum length of 750 words but is not to exceed 1000 words. Students will be evaluated according to the attached rubric: **Critical Writing Response Marking Rubric.**
- **How to avoid plagiarism:** The simplest way to avoid plagiarism is to reference any sources properly (using both in-text, parenthetical citations in the body of your assignment and a 'References' page at the end). While it is commonplace to build upon the knowledge of others, it is necessary to clearly state the sources and foundations of that knowledge. Referencing must conform to the APA style- see your ENG110 text for support.

## **Final Project – Oral Presentation**

**Due Date: Class 10**

**Weight: 20%**

The final project will enable you to explore the entirety of the covered course content **BUT** you will only choose one chapter/topic to discuss in detail in an oral response/presentation.

**Please note that Chapters 2 and 6 are not permitted to be used for this assignment.**

Suggested Chapters:

- Chapter 4: Ideological, Social, and Economic Influences
- Chapter 5: Social Policy and Emerging Realities
- Chapter 7: Social Policy and Social Work Practice
- Chapter 8: Social Policy Analysis
- Chapter 9: Future Directions in Canadian Social Policy and Social Welfare

Your presentation should be more than a review of material in the text, but rather an expanded, more thorough learning that may be relevant to you now or in the future as a social service worker. Make connections to your personal/professional/academic learnings.

### **Writing Assignments Expectations:**

- **Objective:** The objectives of the two writing assignments are to critically apply concepts, ideas, and procedures to facilitate higher level learning. The assignments are designed so students can demonstrate depth of knowledge related to the course content.
- **Focus:** Each assignment is designed to apply knowledge from the chapters and class discussions.
- **Format:** Present to the class, your findings using a presentation tool such as PowerPoint or another approved format. Students will be marked using: **Oral Presentation Rubric**
- **How to avoid plagiarism:** The simplest way to avoid plagiarism is to reference any source properly (using both in-text, parenthetical citations in the body of your assignment and a “References” page at the end. While it is commonplace to build upon the knowledge of others, it is necessary to clearly state the sources and foundations of that knowledge. Referencing must conform to the APA referencing formats outlined in your ENGL110-1 texts (chapters vary).
